## Law Society bid for regional election turned down by court

The May 1995 benchers elections will not take place according to the regional scheme adopted by the Law Society two years ago. An application to the Ontario Court (General Division) seeking an interpretation of *The Law Society Act* that would have allowed regional elections to be implemented according to the Society's rule-making powers was turned down on January 6th by Mr. Justice Stephen Borins.

In his written decision, Mr. Justice Borins indicated that only the Ontario legislature has the power to determine how benchers are elected. Although the Attorney General supported the Society's application, the court held that it did not have the power to make the necessary rules and that while the business of the Society was to govern the legal profession that did not include the determination that benchers be elected on a regional basis.

"Convocation remains under the control of, and accountable to, the legislature," Mr. Justice Borins wrote.

"The governance of members of the Society is a fundamental matter of policy which must be regulated by primary or subordinate legislation... Any fundamental or substantive change in how the benchers are

elected is a matter of policy for the legislature."

The Society had brought the application before the court after it learned that the Attorney General

would be unable to pass the necessary legislative amendments in time for the upcoming benchers election in May. As a result of the court ruling, *continues...*

## Proposal to pay benchers defeated

A proposal brought forward by the Women in the Legal Profession Committee recommending that benchers be paid at legal aid tariff rates for the work they do on behalf of the Law Society was defeated by benchers by a vote of 16 to 10.

While recognizing that the recent crises in legal aid and insurance would make it difficult to generate support for the proposal, the committee's report argued that in order to improve accessibility to benchers office and encourage greater participation by women and others who may be unable to bear the financial burden of benchers duties, the Society should offer elected benchers the choice of compensation at about \$67 per hour.

According to a 1992 survey, benchers spend approximately 50 hours per month on Law Society business. Not all the time spent on Society matters would qualify for

compensation according to the committee's report but it was suggested, for example, that benchers may choose to be compensated for attendance at Convocation, committees and subcommittees.

Per diem rates for members of some governing bodies range from a high of \$725 per day for members of the Royal College of Dental Surgeons to \$150 per day for members of the College of Nurses. Presently, Law Society benchers receive no remuneration for their work but are reimbursed for travel, accommodation and meal expenses when they attend in Toronto on Society business. The Treasurer receives a yearly honorarium of \$75,000.

The Society's four lay benchers who are appointed by the provincial government may elect to receive a per diem of up to \$175 which is paid by the Ministry of the Attorney General.



that election will now take place pursuant to the existing legislation which provides that 40 members be elected at large—20 from outside Metropolitan Toronto and 20 from within.

Under the proposed scheme, nine of the 40 benchers would have been elected on a regional basis—one from each of the seven judicial regions outside Metro Toronto and two from the Metro Toronto judicial region.
