

MINUTES OF SPECIAL CONVOCATION

Mr. Jack Miller was sworn as a witness and examined in-chief by Mr. Roach.

Mr. Marrocco cross-examined the witness.

There being no re-direct examination the witness retired.

Louis Dowson-Bedard was sworn as a witness and examined in-chief by Mr. Roach.

A paperback book entitled Ross Dowson versus the R.C.M.P. was filed. (marked Exhibit 3).

There was no cross-examination and the witness retired.

Mr. Roach requested that Mr. Kopyto be recalled to describe the particular case involving the R.C.M.P. which was dealt with in Exhibit 4 a series of cases which were to be filed by Mr. Roach.

It was the ruling of Convocation that Mr. Roach prepare a memorandum and submit it with other cases.

Hugo Alba was sworn as a witness.

Mr. Epstein indicated that he had acted for Mr. Alba and asked if there was any objection to him sitting. Mr. Roach indicated there was no objection to Mr. Epstein continuing to sit.

There was no cross-examination by Mr. Marrocco and no re-direct examination and the witness retired.

Mr. Del Rio made submissions as to penalty on behalf of Mr. Kopyto.

Mr. Shaffer withdrew at this point as he was unable to stay for the completion of the matter.

Mr. Del Rio continued his submissions.

It was moved by Mr. Strosberg, seconded by Ms. Peters that Convocation adjourn to a date to be set.
