## New LPIC president to usher in E&O changes

The Law Society has appointed a new president to head up the Lawyers' Professional Indemnity Company (LPIC). Malcolm Layton Heins, 44, an Ontario lawyer and insurance executive with a Burlington-based firm, will take over the helm of LPIC on December 5th.

Mr. Heins is leaving behind his post as president and chief operating officer of the Simcoe Erie Group (now GAN Canada), a company that specializes in liability insurance for professionals such as engineers and architects, among others. During his fourteen-year career with that firm, he acquired extensive experience in all aspects of insurance operations, including claims underwriting and management. Mr. Heins was a former partner in the law firm of Thomson Rogers.

As the new insurance president, Mr. Heins will focus on developing LPIC's underwriting capability to an appropriate standard for the industry and will assemble a professional team of senior managers in core areas such as finance and operations. He will also begin the task of installing effective information management systems that will allow LPIC to gather data about claims experience for the purpose of developing more sophisticated risk and rating structures.

LPIC has already taken a number of steps to remedy the administrative and management deficiencies identified by the insurance task force mandated to investigate the causes of its \$154 million deficit. Changes have been instituted to reduce defense costs: a tendering process is being developed

for the selection of outside counsel and, coverage opinions formerly provided by outside counsel, will now be developed by LPIC through in-house counsel hired for that purpose.

In addition, a number of changes have been made to LPIC's claims operations such as the hiring of additional examiners to expedite the handling and closing of claims. The Society has also appointed Deloitte Touche as the new external auditors of the insurance program.

In addition to these administrative

changes, the Society has also made changes to the accountability structure of LPIC's board which is to report every two months to Convocation. LPIC's board has been expanded from six to fourteen members comprising all benchers members of the insurance committee as well as individuals knowledgeable in the areas of insurance, finance and business. This has been done to eliminate duplication between the insurance committee and the LPIC board and to ensure effective accountability.

## 1995 benchers election update

The Society's quadrennial election of benchers will take place in the spring of 1995. On November 16, 1994, the Society brought an application before the Ontario Court (General Division) for an interpretation of *The Law Society Act* to determine whether the Society has the power to implement a system of regional elections through its rule-making powers. The Society had planned to effect regional elections by amendments to its Act; however, the Ontario Government has advised that it is unable to accommodate this request on its upcoming legislative agenda.

The court has reserved its decision. Should it decide that the Society has the necessary power to implement regional elections by changes to its rules, Convocation will make the necessary amendments so that at the 1995 election, nine of the forty benchers will be elected by and from members in nine

electoral regions. With the exception of Metro Toronto, which has been divided into two separate regions, the remaining seven electoral regions correspond to judicial regions as designated under the *Courts of Justice Act*. Under the regional election scheme, the candidate in each region who receives the greatest number of votes automatically becomes the regional benchers.

A candidate guide will be mailed with ballots to all members eligible to vote in early April. Ballots must be returned to the Society by 5 p.m. on Monday, May 1, 1995.

## Office of life bencher to be eliminated

Benchers at the November Convocation voted to eliminate the office of life bencher following the next bencher election. Currently, benchers who have served four consecutive four-year terms are eligible to become life benchers—an office which allows them to sit and vote on Law Society committees. Life benchers are not eligible to vote at Convocation. Existing life benchers and those eligible to become life benchers at the conclusion of the current bencher term in May 1995 will continue to hold that office.

A motion by Toronto benchers Fran Kiteley and Dennis O'Connor to prevent benchers from holding office for more than two continuous terms was lost in a roll-call vote.

1. That the Law Society Act be amended to provide that a bencher who has been elected and served two full consecutive terms be required to sit out a term before being nominated for election for a third time. Lost 22 to 9.

2. That the Law Society Act be amended to provide that the office of life bencher arising from continuous service as an elected bencher be eliminated. This would not apply to incumbent life benchers. Carried 18 to 12.

3. That motion #2 not apply to incumbent elected benchers who are eligible to become life benchers at the end of the current term in 1995. Carried 20 to 11.
