CALL TO THE BAR

The ceremony of Call to the Bar takes place in two separate procedures. First, the Benchers of The Law Society of Upper Canada, who are responsible for the government of the legal profession in Ontario, are called to order on the stage in a Special Convocation by the Treasurer, who is

the head of the Society. The candidates will be presented by a representative of the Admissions and Equity Committee to the Treasurer who will confer on them the degree of Barrister-at-Law and call them to the Bar of Ontario. Convocation will then adjourn and a Special Session of The Court of Appeal for Ontario and The Ontario Court of Justice (General Division) will be convened by the Registrar. The Chief Justice of Ontario or his designate will preside over the administering of the Oath of Allegiance, the Barristers Oath and the Solicitors Oath, to the newly called members of the Bar. The Court will then adjourn. Upon completion of these two ceremonies the graduates become Barristers and Solicitors, authorized to practise law in the Province of Ontario.

ADMISSION AU BARREAU

La cérémonie entourant l'admission au Barreau se déroule en deux temps. En premier lieu, le trésorier, qui est chef de la direction du Barreau, ouvre un Conseil extraordinaire sur l'estrade des conseillers du Barreau du Haut-Canada, qui sont responsables de l'administration de la profession juridique en Ontario. Une représentante ou un représentant du Comité d'admission et d'équité présente les candidats et candidates au trésorier qui leur remet le diplôme d'avocat-plaideur ou d'avocate-plaideuse et les reçoit au Barreau de l'Ontario. La séance du Conseil est alors levée et le greffier convoque une session extraordinaire de la Cour d'appel de l'Ontario et de la Cour de justice de l'Ontario (Division générale). Le juge en chef de l'Ontario, ou la personne qu'il désigne, préside à la prestation du serment d'allégeance, du serment des avocats-plaideurs et de celui des procureurs par les nouveaux membres admis au Barreau. La séance de la Cour est alors levée. À l'issue de ces deux cérémonies, les diplômés et diplômées deviennent avocats-plaideurs ou avocates-plaideuses et procureurs ou procureures, et sont autorisés à exercer le droit dans la province de l'Ontario.

OATH OF ALLEGIANCE

You shall not be guilty of champerty or maintenance. You shall not refuse causes of complaint reasonably founded, nor shall you promote suits upon frivolous pretences. You shall not pervert the law to favour or prejudice any one, but in all things shall conduct yourself truly and with integrity. In fine, the Queen's interest and the interest of citizens you shall uphold and maintain according to the constitution and law of this Province. All this you do swear to observe and perform to the best of your knowledge and ability. So help you God.

SOLICITORS OATH

You also do sincerely promise and swear that you will truly and honestly conduct yourself in the practice of a solicitor according to the best of your knowledge and ability. So help you God.
