MESSAGE FROM THE TREASURER

You are being called to the bar in a very special year for the Law Society of Upper Canada. Two hundred years ago on July 17, 1797 in what is now Niagara-on-the-Lake, ten lawyers gathered to form the Law Society of Upper Canada. The face of the law has changed dramatically over those two centuries reflecting the phenomenal changes in the society lawyers serve. What has lasted, however, and it is testimonial to the foresight of the founding members of the Law Society, is our commitment to justice and our dedication to govern the legal profession in the public interest.

It has been the practice since 1801 – the year the first qualified candidates were presented – that the call to the bar take place at Convocation. While the growing number of applicants made it necessary to physically move the event outside of Osgoode Hall, the ceremony is still conducted at special meetings of Convocation – in Toronto, Ottawa and London.

The call to the bar itself has undergone some change over the years. The events we know today, with their speeches, pageantry and social reception are relatively new, coming about in 1936. Prior to

LE MESSAGE DE LA TRÉSORIÈRE

Votre admission au barreau coïncide avec une année très importante pour le Barreau, car il y a deux cents ans, le 17 juillet 1797, dix avocats fondaient le Barreau du Haut-Canada là où se trouve maintenant Niagara-on-the-Lake. Ces deux siècles ont été marqués par l'évolution spectaculaire du droit, qui fait pendant aux bouleversements phénoménaux qui se sont produits dans la société à laquelle les juristes se dévouent. Ce qui n'a pas changé et témoigne de la prescience des membres fondateurs du Barreau, c'est notre attachement à la justice et notre volonté de réglementer la profession dans l'intérêt public.

L'assermentation se déroule en Conseil depuis 1801, l'année de la présentation des premiers candidats qualifiés. Bien que le nombre croissant de candidates et de candidats nous ait conduits à délaisser Osgoode Hall, la cérémonie a toujours lieu lors d'un Conseil extraordinaire – à Toronto, à Ottawa et à London.

La cérémonie a, elle aussi, connu certaines transformations au fil des ans et elle date, sous sa forme actuelle, d'une époque relativement récente, aux alentours de 1936. Les discours, le faste et la réception n'étaient pas de mise auparavant,

that the process consisted of candidates being presented at Convocation with certification that they were fit to practise law; oaths were sworn and the rolls signed.

A big component of the modern call to the bar is the festive atmosphere in which graduates get to celebrate the day with friends and family and to reflect on their future in the profession of law. The call to the bar was once an opportunity for one final test when in the earlier part of the 19th century, being called included oral examinations given right in Convocation.

I congratulate the candidates being called to the bar in this the Law Society's bicentennial year. I trust that each of you will strive to add to the legacy of professionalism and dedication which have been the hallmarks of Ontario's lawyers for the past 200 years.

CALL TO THE BAR**ADMISSION AU BARREAU**

The ceremony of Call to the Bar takes place in two separate procedures. First, the Benchers of The Law Society of Upper Canada, who are responsible for the government of the legal profession in Ontario, are called to order on the stage in a Special Convocation by the Treasurer, who is the head of the Society. The candidates will be presented by a representative of the Admissions and Equity Committee to the Treasurer who will confer on them the degree of Barrister-at-Law and call them to the Bar of Ontario. Convocation will then adjourn and a Special Session of The Court of Appeal for Ontario and The Ontario Court of Justice (General Division) will be convened by the Registrar. The Chief Justice of Ontario or his designate will preside over the administering of the Oath of Allegiance, the Barristers Oath and the Solicitors Oath, to the newly called members of the Bar. The Court will then adjourn. Upon completion of these two ceremonies the graduates become Barristers and Solicitors, authorized to practise law in the Province of Ontario.

La cérémonie entourant l'admission au Barreau se déroule en deux temps. En premier lieu, la Trésorière, qui est chef de la direction du Barreau, ouvre un Conseil extraordinaire sur l'estrade des conseillers du Barreau du Haut-Canada, qui sont responsables de l'administration de la profession juridique en Ontario. Une représentante ou un représentant du Comité des admissions et de l'équité présente les candidats et candidates à la Trésorière qui leur remet le diplôme d'avocat-plaideur ou d'avocate-plaideuse et les reçoit au Barreau de l'Ontario. La séance du Conseil est alors levée et le greffier convoque une session extraordinaire de la Cour d'appel de l'Ontario et de la Cour de justice de l'Ontario (Division générale). Le juge en chef de l'Ontario, ou la personne qu'il désigne, préside à la prestation du serment d'allégeance, du serment des avocats-plaideurs et de celui des procureurs par les nouveaux membres admis au Barreau. La séance de la Cour est alors levée. À l'issue de ces deux cérémonies, les diplômés et diplômées deviennent avocats-plaideurs ou avocates-plaideuses et procureurs ou procureures, et sont autorisés à exercer le droit dans la province de l'Ontario.

OATHS

OATH OF ALLEGIANCE

You do swear that you will be faithful and bear true allegiance to Her Majesty Queen Elizabeth the Second, Her heirs and successors according to law. So help you God.

BARRISTERS OATH

You are called to the Degree of Barrister-at-law to protect and defend the rights and interest of such citizens as may employ you. You shall conduct all cases faithfully and to the best of your ability. You shall neglect no one's interest nor seek to destroy any one's property. You shall not be guilty of champerty or maintenance. You shall not refuse causes of complaint reasonably founded, nor shall you promote suits upon frivolous pretences. You shall not pervert the law to favour or prejudice any one, but in all things shall conduct yourself truly and with integrity. In fine, the Queen's interest and the interest of citizens you shall uphold and maintain according to the constitution and law of this Province. All this you do swear to observe and perform to the best of your knowledge and ability. So help you God.

SOLICITORS OATH

You also do sincerely promise and swear that you will truly and honestly conduct yourself in the practice of a solicitor according to the best of your knowledge and ability. So help you God.
