DISCIPLINE

Ms. Lesley Cameron, Senior Counsel - Discipline introduced Mr. Neil Kozloff who acted as Duty Counsel.

Ms. Cameron appeared on behalf of the Society and Mr. Kozloff, Duty Counsel appeared on behalf of the solicitor. The solicitor was not present.

An adjournment was requested by both counsel on consent to April 27th, 2000.

The adjournment was granted by Convocation peremptory to the solicitor.

Re: Angelina Marie CODINA - Toronto

The matter was placed before Convocation.

Mr. Swaye withdrew for this matter.

Ms. Jane Ratchford and Ms. Catherine Braid appeared on behalf of the Society and the solicitor appeared on her own behalf.

The Report of the Discipline Committee dated June 22nd, 1999 together with the Affidavit of Service was filed as Exhibit 1.

Ms. Codina requested an adjournment so that she could be represented by Mr. Joseph Markin. A letter from Mr. Markin dated January 27th, 2000 was filed indicating that he was ill and unable to attend.

Ms. Ratchford, counsel for the Society opposed the request for an adjournment.

There was a reply by the solicitor.

Counsel, the solicitor, the reporter and the public withdrew.

The Benchers discussed the adjournment request in camera.

It was decided that the request be denied.

Counsel, the solicitor, the reporter and the public returned and advised that the adjournment request was denied and that Convocation would hear submissions on the jurisdictional motion.

The solicitor proceeded with her jurisdictional argument regarding section 9 of the Regulation made pursuant to the Law Society Act.

The Law Society's counsel, Ms. Ratchford gave submissions in response.

The Treasurer put on record that Mr. Richard Tinsley would not be present at the in camera sessions.

Convocation took a brief recess at 11:45 a.m. and resumed at 12:00 noon.

Mr. Ratchford continued with her submissions.

There were questions from the Bench.

The solicitor made submissions in reply.


The Treasurer directed the solicitor and counsel for the Society to submit written argument on the jurisdictional issue and asked that they address the following:

- (a) the issue of implied delegation of authority by the Secretary to others with reference to section 22 of the Rules;
- (b) the applicability of the Carltona case;
- (c) who has the onus of proof in respect of challenges to a tribunal to jurisdiction;
- (d) if the onus lies with the defendant, does the fact that the Society acknowledges that the Secretary did not sign the Authorization Memorandum, a shift the evidentiary burden to the Law Society;
- (e) a review of administrative law cases;
- (f) the interpretation of implied delegation and the construction of the words "shall refer" and "in his or her opinion".

The Treasurer directed that the written arguments be not more than 30 pages. The solicitor is to submit her written argument by February 15th, the Law Society's response is to be delivered by February 22nd and the solicitor's reply by February 29th, the reply by the solicitor not to be more than 10 pages. The written arguments are to be directed to the Treasurer, care of Marilyn McDonald.
