## TARIFF UPDATE

The Law Society's proposals for changes to the Tariff were presented to the Attorney General in December, 1983. Since then, a number of meetings have been held to discuss the Society's recommendations. As well, over 5,000 cards urging the Attorney General to support the Canadian Bar Association - Ontario's call for a substantial Tariff increase have been received. In addition, many members of the Bar have written to MPPs indicating their support for the Society's and CBA-O's recommendations.

The Government is currently considering changes to the Tariff.

## 1983-84 IN REVIEW

Figures for the fiscal year ended March 31, 1984 show that 237,429 people contacted the Plan's 47 Area Offices compared with 243,224 during the same period in 1982-83 — a drop of about 2.5%. Of the 237,429, 122,358 made an application for legal aid compared with 124,811 last year. A total of 89,984 certificates were issued, compared with 90,892 in the previous year.

Duty Counsel activity in the Provincial Courts rose by 1.7% during the year from 244,626 to 248,725.

## YOUNG OFFENDERS ACT

Under the Young Offenders Act, alleged young offenders must be given the opportunity to retain and instruct counsel without delay. Earlier this year, The Law Society, through its Lawyer Referral Service, compiled lists of lawyers willing to make themselves available to juveniles who

may be in need of legal services *outside of normal business hours*. These lists were then circulated to all municipal and regional police forces as well as to the O.P.P. and the R.C.M.P.

Members wishing to add or delete their names from the lists maintained by the O.P.P. only are asked to contact their local O.P.P. detachment. The Lawyer Referral Service will update its Province-wide listings later this year after information about the program's performance is evaluated.

## ANNUAL REPORT - 1983

The Plan's Annual Report for the year ended March 31, 1983, is now available for distribution. Quantities are being made available to all Area Offices and clinics and have been sent to all Ontario media.

## LE TARIF À LA UNE!

En décembre 1983, la Société du Barreau du Haut Canada remettait au Procureur général ses recommandations au sujet d'une hausse du tarif de l'Aide juridique. Ces recommandations ont depuis fait l'objet de nombreuses rencontres et plus de 5 000 personnes ont fait parvenir leur carte au Procureur général, à l'appui de l'Association du Barreau canadien-Ontario qui recommande aussi une hausse substantielle du tarif. De nombreux avocats ont également écrit à leur député, appuyant les recommandations de la Société du Barreau et de l'ABC-Ontario.

À l'heure actuelle, le gouvernement étudie les changements proposés.

## COMPTE RENDU POUR 1983-84

Les statistiques concernant l'exercice financier qui a pris fin le 31 mars 1984 révèlent que 237 429 personnes se sont adressées aux 47 bureaux régionaux de l'Aide juridique par rapport à 243 224 pendant le même période en 1982-83. Ce chiffre représente une baisse d'environ 2,5%. De ce nombre, 122 358 personnes ont fait une demande de certificat d'aide juridique, par rapport 124 811 l'année dernière. Le nombre des certificats émis était en baisse cette année, passant de 90 892 l'année dernière à 89 984 cette année.

Les avocats de service auprès des tribunaux de la Cour provinciale ont assisté 248 725 personnes, ce qui représente une hausse de 1,7% par rapport aux 244 626 personnes auxquelles ils sont venus en aide l'année dernière.

## LOI SUR LES JEUNES CONTREVENANTS

Aux termes de la *Loi sur les jeunes contrevenants*, le présumé contrevenant a le droit d'obtenir sans retard

les services d'un avocat. Plus tôt cette année, la Société du Barreau a compilé, par l'intermédiaire de son Service de référence juridique, une liste des avocats prêts à se rendre disponibles aux jeunes contrevenants qui peuvent avoir besoin de leurs services *en dehors des heures normales de travail*. Ces listes ont été transmises à tous les corps de police municipaux et régionaux, de même qu'à la police provinciale de l'Ontario (OPP) et à la GRC.

Les avocats qui désirent que leur nom soit ajouté aux listes conservées par la police provinciale seulement (ou retiré de celles-ci) doivent communiquer directement avec la police provinciale de leur localité. La mise à jour des listes provinciales du Service de référence juridique sera effectuée plus tard cette année après l'évaluation du rendement de ce programme.

## RAPPORT ANNUEL - 1983

Le rapport annuel de l'Aide juridique pour l'année qui a pris fin le 31 mars 1983 est maintenant disponible. On a fait parvenir des exemplaires de ce rapport à toutes les cliniques et bureaux régionaux ainsi qu'à tous les média d'information de l'Ontario.

# Ontario Legal Aid Plan

## IMPORTANT NOTICE - DISBURSEMENTS

EFFECTIVE AUGUST 1, 1984

### SOLICITORS' OUT-OF-POCKET DISBURSEMENTS WHICH DO NOT REQUIRE PRIOR APPROVAL

#### CIVIL DISBURSEMENTS

1. In an action for damages arising out of personal injuries, or a medical malpractice action, a medical report may be obtained by the solicitor without authorization to assist him/her in preparing an opinion for the Area Director, providing the cost of the report does not exceed the sum of \$75 for a general practitioner and \$150 for a specialist.
2. After authorization to proceed with an action has been obtained from the Area Director, a medical report may be obtained from a doctor who has previously treated the client with respect to the matter in litigation, provided the total cost of the report so obtained is less than 10% of estimated damages set out in the solicitor's letter of opinion, upon which authorization to proceed has been based. In those instances where more than one doctor has treated the client, a maximum of three such reports may be ordered, provided the total cost remains within the 10% limit outlined above.
3. In a divorce action based on cruelty, the following may be obtained without prior authorization: (a) a medical report from the Family doctor, at a cost of not greater than \$75, or, if appropriate, (b) copies of hospital records at a cost not to exceed \$35 per record, or (c) a report from a medical specialist not to exceed the cost of \$150.
4. In proceeding to obtain support from one's spouse, which claim is based on employability, a solicitor may obtain a medical report confirming unemployability without prior authorization, at a cost not to exceed \$75.

#### CRIMINAL DISBURSEMENTS

1. A solicitor may obtain a report without prior authorization for the purpose of speaking to sentence where the client has been consulting a physician whose report would relate to the circumstances of the crime, provided the cost does not exceed \$75.
2. Where a client is charged with murder or sexual assault under Sections 246(1); 246(2) or 246(3), a solicitor may obtain a psychiatric assessment and report, without prior authorization, from a psychiatrist, provided the total cost does not exceed \$300, calculated at four hours for the assessment and report at \$75 per hour. Or a solicitor may obtain an assessment and report, without prior authorization, from a psychologist registered with the Province of Ontario, provided the total cost does not exceed \$264, calculated at four hours for the assessment and report at \$66 per hour.
3. If a client is charged with an offence under Group I or II of Schedule 2 of the Legal Aid Tariff, and if the defence involves the ingestion of both drugs and alcohol, a report may be obtained, without prior authorization, from a pharmacologist, to a maximum of four hours at a cost of \$60 per hour; or from a toxicologist at a cost of \$66 per hour to a maximum of four hours; or from a psychiatrist at a cost of \$75 per hour to a maximum of four hours. A solicitor is entitled to obtain only one of such reports without prior authorization.
4. If a client is charged with murder, the solicitor may obtain one report, without prior authorization, from a pathologist up to a maximum of four hours at \$75 per hour.

#### REMINDER TO THE PROFESSION

#### PRIOR APPROVAL IS NOT REQUIRED FOR THE FOLLOWING DISBURSEMENTS:

1. To order a transcript of a Preliminary Hearing or Examination for Discovery providing it is not expedited.
2. To pay witness fees when the witness fees are paid in accordance with Tariff B of the Rules of Practice in civil matters, and The Administration of Justice Act in criminal matters. (A solicitor in submitting an account should provide details of how the witness fee and conduct money have been calculated).
3. Fees paid to agents in Ontario, providing the fees are calculated in accordance with the Legal Aid Tariff. Solicitors should be aware that preparation done by agents is included in the maximum fees provided for preparation, which will be allowed on the solicitor's account. If a solicitor requires an agent outside of Ontario, the solicitor should contact either Mrs. Glyde Hone, Deputy Director, Appeals, or Maryanne Loch, Assistant to the Deputy Director, Appeals, in the Provincial Director's office, particularly if the agent is required in another province in Canada, as there are reciprocal agreements with the other Legal Aid Plans.
4. Authorization is not required for fees or disbursements for travel if the purpose of the trip is to attend a (1) bail hearing, (2) preliminary hearing, (3) trial, (4) appeal or (5) discovery. The fees to be allowed for the travel must not exceed 30% of the total fee for services rendered, as determined by the Legal Accounts Officer.
