"George J. Mr. Pollack presents a Certificate of Good Standing, seeks to proceed under Regulation 4(2) and asks permission to be excused from writing the Common Law examination on the basis of his common law related experience and that the Committee will see it as satisfying the interpretation of Regulation 4(2) as set out in the Memorandum to the Admissions Committee of September, 1983 which states: "Candidates qualified to proceed under Regulation 4(2) and who have obtained an approved LL.B. degree within the eight years preceding their application may be taken to have satisfied the requirements of subparagraph (d) which reads - passes a comprehensive examination on the common law in Ontario."

Mr. Pollack's letter of the 7th March, 1990, more specifically describing the nature of his work, was before the Committee for further consideration.

POLICY

1. THE PER CLAIMANT LIMIT

The Secretary reported that the Report from Tillinghast Actuaries has been received with the projected grants that will be paid out of the Fund for the fiscal year 1989-90 and 1990-91 based on the three scenarios that were proposed by the Committee.

The Committee discussed removal of the \$60,000 per claimant limit entirely so that there would be no per claimant limit. There was a discussion of increasing the \$60,000 per claimant limit to \$100,000 and there was a discussion of a 2-tiered system. The 2-tiered system would comprise no per claimant limit for claims arising from the normal solicitor/client relationship while there would be a limit of \$100,000 per claimant on claims arising from the syndication of mortgages or brokerage activities.

RECOMMENDATION: Your Committee recommends that the per claimant limit be increased to \$100,000 for funds advanced to a solicitor on or after the date of approval by Convocation. The Committee did not think it would be wise to remove the per claimant limit altogether because of the possibility of a catastrophic loss and if the limit was removed it would be hard to impose a limit in the future. The vast majority (90% based on Tillinghast report) of the claims to the Fund are under \$100,000.

The two-tiered system could work an unfairness and would be difficult to administer.

The additional cost of increasing the limit to \$100,000 would be \$300,000 in this fiscal year according to the report prepared by Tillinghast.

1. COMPENSATION FUND LEVY FOR 1990-91

The Secretary reported that the Compensation Fund levy should be set for the next fiscal year. In the 1989-90 fiscal year the levy was \$50 per member.

RECOMMENDATION: Your Committee recommends that the Compensation Fund Levy should be \$25 per member for the 1990-91 fiscal year. The Committee thought that a levy of \$50 seemed high and because of a healthy balance in the Compensation Fund a \$25 levy would be sufficient to meet the Fund's estimated expenses in the next fiscal year.

2. RECOVERY RE BRUCE PERREAULT

The Secretary reported that the Fund has paid out \$82,100.00 to former clients of Bruce Perreault. Maria Perreault (Mr. Perreault's wife) is suggesting two payments to the Fund totalling \$17,500.00 as a partial recovery of the grants paid out. Mrs. Perreault has sold shares of a company in order to obtain the funds to pay the Law Society.

RECOMMENDATION: Your Committee recommends that the Society accept \$17,500.00 from Mrs. Perreault on the understanding that Mr. Perreault's obligation to repay the Society the balance of the grants paid out of the Fund remains and that the payment in no way binds a Committee considering a readmission application by Mr. Perreault.

The Chair has suggested that the Society place an advertisement in the Ontario Reports, the Lawyers Weekly, Le Droit, and the Law Times, indicating that the Society wishes to obtain the services of Referees fluent in both of Canada's Official Languages. The advertisement would indicate the qualifications for the position. Applicants would be lawyers, retired lawyers or retired judges.

2. MORTGAGE FINANCING OF BUILDING ADDITION

3. EMPLOYEE PENSION PLAN - ESTABLISHMENT OF A PENSION ADVISORY COMMITTEE

In January the Committee asked for an opinion concerning the Society's responsibility to establish a pension committee and to advise employees with respect to their investments within the pension plan.

The opinion of Osler, Hoskin on the matter is attached and in effect advises that should the members of the plan wish to establish an advisory committee they may do so by majority vote, and that all members and former members of the plan be notified of that vote. The Pension Benefits Act however does not designate the employer as the party responsible for providing such notice, or envisage the employer being involved in the organization of such a vote.

The Committee recommended that the employees be advised of their right to establish an advisory committee.

4. GOODS AND SERVICES TAX

Attached is a letter from Ernst & Young, our auditors, outlining the impact on the Law Society of the proposed Goods and Services Tax.

The Chair, Under Treasurer, and Director of Finance have met with representatives of Ernst & Young to discuss this letter and in essence have determined that the Law Society should elect to be a "taxable organization" for purposes of the Act.

The Committee recommended that the Society should elect to be a "taxable organization".
