



## Attorney General urges cooperation on equity, access

Attorney General Marion Boyd told Law Society benchers that access and equity issues are the most pressing challenges confronting the justice system today. In her address to Convocation on January 28, Ms. Boyd urged the Society to work closely with her Ministry to enhance access to legal services and to ensure more equitable representation of minority groups within the justice system.

The Attorney General commended the on-going efforts of the Society's Equity Committee, which was established in 1991 to facilitate the representation of minority groups in the legal profession. The committee is now in the process of developing a comprehensive rule of professional conduct on non-discrimination (known as draft Rule 28) which mirrors the provisions of the Ontario Human Rights Code. Ms. Boyd said that as guardians of the justice system, the Law Society and the legal profession have a duty not only to meet the standards of the human rights code but also to out-

perform other organizations and professions in doing so.

"We cannot expect the public to be confident that lawyers are advising their clients wisely about their human rights obligations if the profession itself is seen to be unknowledgeable about, or resisting, current human rights jurisprudence," the Attorney General told Convocation.

"I would urge the Law Society to continue with its efforts to set clear standards which leave no doubt about the profession's commitment to meeting all human rights obligations."

Ms. Boyd praised the efforts of the Society in working with her Ministry to find constructive solutions to the financial difficulties facing the Legal Aid Plan. The family and refugee law pilot projects developed jointly by the Ministry, the Law Society and the Legal Aid Plan

are indicative of Ontario's willingness to evaluate new approaches to the delivery of legal services, Ms. Boyd said.

Ms. Boyd also expressed hope that the Law Society would approve a womens' legal clinic that would provide family law legal services in addition to counselling, translation and other social services. The proposal to set up such a clinic was defeated by benchers in November on the grounds that it failed to meet affirmative-action criteria.

Ensuring that defaulting lawyers pay their family support payments, increasing interest income earned by the Law Foundation and regulating paralegals are some of the initiatives that Ms. Boyd said would require future joint action between her Ministry and the Law Society.

## Update on GST Disbursements

Recently, Revenue Canada auditors in the Kingston, Peterborough and Ottawa area were advising lawyers to charge GST on disbursement items that had not been subject to GST in the past.

Two solicitors have appealed their audits (GST assessments). The Law Society has retained counsel and an agreement has been reached with the Kingston District Office of Revenue Canada (Excise) that no more GST assessments would be conducted in that area until the results of the appeal are known.

The Law Society wants to hear from lawyers who have experienced the same problem with GST assessments in other areas of the province. The Law Society will seek to make arrangements with the local district offices of Revenue Canada to postpone GST assessments until the issue of disbursement exemptions has been resolved.

## Criminal deduction cut in legal aid budget

Demand for legal aid certificates in criminal and refugee law is expected to decrease according to projections made in the Legal Aid Plan's budget for the 1994/95 fiscal year beginning April 1. The \$269 million budget was approved by Law Society benchers in January.

An additional five per cent deduction (over and above the mandatory statutory deduction of five per cent) that criminal lawyers have been required to forfeit on their fees since 1992 will be lifted as originally promised on May 1, 1994.

The Ontario Government will be required to increase its contribution to the Plan by \$2.6 million next year to cover the costs of the family and refugee law pilot projects.

## Insurance head retires

Lin Whitman, the Law Society's director of insurance since 1990, retired on January 31. Mr. Whitman, a 40-year veteran of the insurance industry, was the president of the Canadian Indemnity Company prior to joining the Law Society.

Edwin J. Anderson, formerly of Dominion of Canada General Insurance Company, has taken over as President of the Lawyers Professional Indemnity Company. He has been in the insurance business for almost 35 years.
